  - Consistent problem with a Suburban B team coach—coach received a written warning

  - Reminder about wearing PROPER uniform
  - Shot Clocks: All Suburban games must have shot clocks! There is an App for the phone that table personnel can use if need be. Have a discussion with coaches pregame.
  - COMMUNICATION—is key, with your assignor, game partner, facility admin, in the event you will be late, or a game is cancelled, etc..
  - Please make sure to keep your officiating experiences OFF SOCIAL MEDIA, there are consequences. It is NOT the place to discuss any issues.

- E. Mike Lavelle Scenarios:
  - Important note—Time outs do NOT mean TIME OFF
  - Player Injury—Whoever subs in for an injured player MUST be the player to shoot any foul shots that have been awarded
  - Scenario 2—Time expired as a player was attempting a shot at the basket, and the player was fouled. The result would be the player shoots the free-throws with the lanes cleared.
  - Scenario 3—A drive to the basket, shot clock horn sounds and ball gets wedged between the backboard and rim—Offensive team has possession arrow, so they receive a throw in at the designated spot on the endline, and the shotclock is reset to 35.

- Scenario 4—Whatever the team foul count is in the 4<sup>th</sup> quarter, remains the same in the extra period (it is just an extension).
